IN CONSIDERATION of being permitted to participate in any way in the training activities under the auspices of One Shepherd and TacComp Media, LLC, and for other good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, I acknowledge, appreciate and agree that:

1. The risk of injury from the activity and weaponry involved is significant, including the potential for permanent disability and death, and while particular protective equipment and personal discipline will minimize this risk, and the risk of serious injury does exist.
2. There is the chance of being injured by running into or falling from props, vehicles, uneven terrain, trees, wild animals, other participants and undesirable vegetation as a result of physical training outdoors.
3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE of those persons released from liability herein, and assume full responsibility for my participation; and
4. I understand that the activities of physical training are physically and mentally intense. I understand the rules of training and will comply with all rules and regulations. If I observe any unusual or unnecessary hazard during my participation, I will bring such to the attention of the nearest official as soon as practical (my continued training activity after such notification does not constitute a waiver of this release); and
5. I may choose to cease training and vacate the property at any time during an event but, will notify an official prior to that choice so that all who begin training are accounted for; and
6. On behalf of myself and on behalf of my heirs, assigns, personal representatives and next of kin, I HEREBY RELEASE One Shepherd and TacComp Media, LLC and all of those persons acting by, through or on behalf of One Shepherd and TacComp Media, LLC or otherwise involved in conducting the training activities ("Releasees") which includes, but is not limited to, owners of property used, WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH and loss or damage to person or property, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE. I also agree to INDEMNIFY AND HOLD HARMLESS the Releasees from all claims, judgments and costs, including attorney's fees, incurred in connection with any action brought as a result of my participation in or observation of the activities of training with One Shepherd, a Division of TacComp Media.
7. I understand and agree that this Release of Liability Agreement covers each and every training activity and event in which I participate on this date and hereafter.
